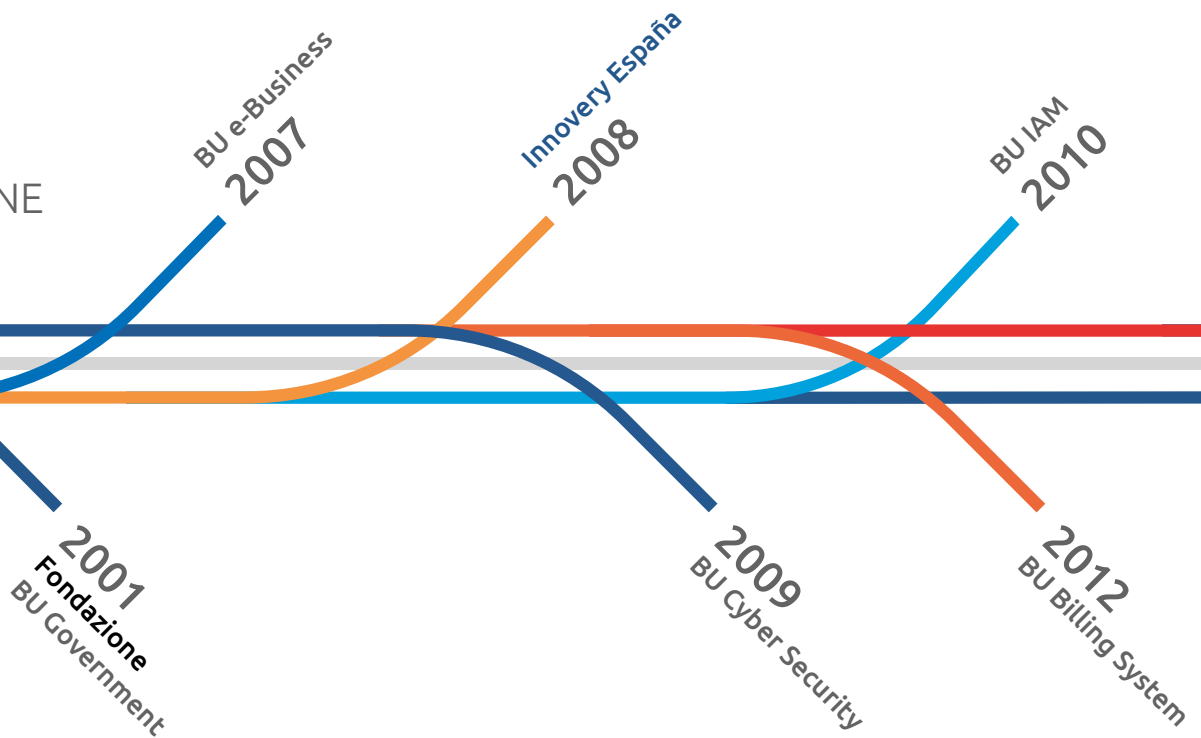
The business development project foresees, in the next three years, the expansion and technological development of the current offices, the opening of new offices around the world and the differentiation of the offering of services and solutions.

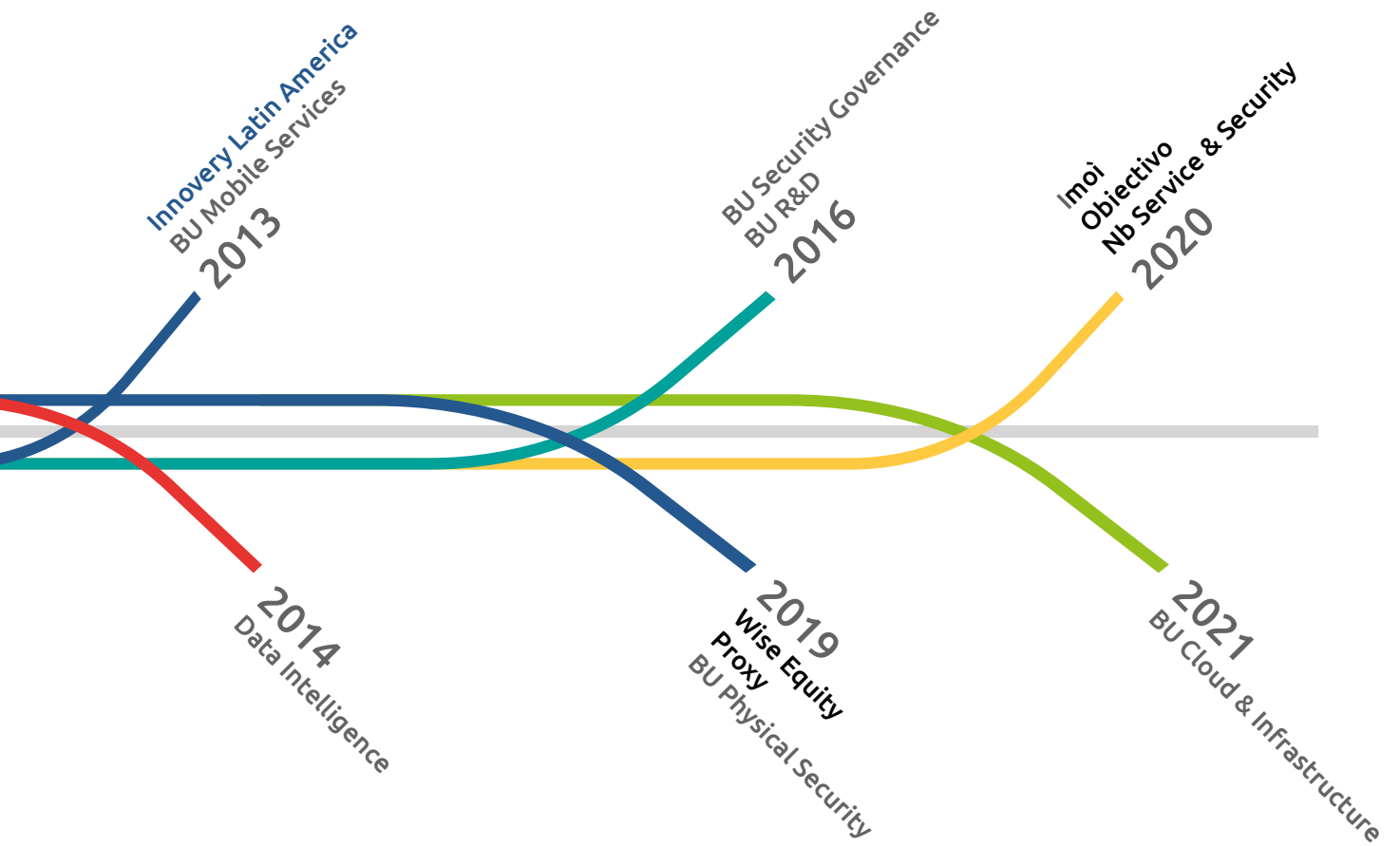


Timeline
